My office represents Township of Mantua with regard to the above-referenced matter. Your Honor signed an Order on May 25, 2006 allowing the withdrawal of monies deposited with the Trust Fund Unit and directing same be paid to the Defendants. The Order was promptly forwarded to the Trust Fund Unit. Thereafter the Trust Fund Unit changed their procedure and would not honor the Order as drafted. I was unaware that they were not honoring the Order until a clerk finally responded to my repeated requests for the status of the release of the monies.

Under cover of correspondence dated July 25, 2006 my office forwarded an amended Order for signature to Your Honor which language complied with the new procedures from the Trust Fund Unit. Consistent with the new procedures the Order needed to be either Certified, allowing my office to forward it to the Trust Fund Unit, or the Order needed to be sent directly by Chambers. The Court forwarded the Order directly to the Trust Fund Unit.
